Dear Members of Congress,

The undersigned organizations write to urge that you preserve the Public Service Loan Forgiveness (PSLF) program. This program, enacted with bipartisan support during the Bush Administration, has given Americans from every region of the country the ability to take and remain in critically needed public service jobs, including those in underserved communities.

College or graduate degrees are increasingly a prerequisite for employment. The debt that students incur in obtaining those degrees often compels them to work in the private sector rather than in lower-paying public service positions. As a result, public service employers, in both urban and rural areas, have difficulty recruiting and retaining talented employees.

By forgiving the remaining student loan debt of persons who have served ten years in qualifying public service employment and made consistent payments on their eligible student loans, PSLF creates incentives for motivated and committed individuals to pursue careers in public service. The program has become an important tool for attracting and retaining talented individuals to work in critical jobs within their communities – as educators, firefighters, police officers, librarians, nurses, social workers, veterinarians, prosecutors, state and local government employees, and so many other professionals.

Eliminating PSLF would result in fewer individuals pursuing careers that are integral to the health and well-being of our society and would deprive many Americans of the services they need in their schools, hospitals, courtrooms and neighborhoods.

The PSLF program is an investment in our nation's values of public service and community involvement. We ask that you preserve it. Thank you for your consideration.
